Note: You are been scored prior to pageant. On day of pageant, judges will score you only on the following categories: 1. Introduction, 2. Evening Dress, 3. On Stage Judges Questions, 4. \*Swimsuit.

All scores for each will be from 1 – 75 \* Swimsuit is voluntary so no score will be given.

**Note: Prior to the crowning day, you had been scored on the following categories:** 1. Talent (Karaoke night), 2. Charity fundraising, 3. Nonprofit Volunteer, 5. Red carpet appearances, 4. Ticket sales, 5. Sponsor ads sales, 6. Public speaking, 7. Rehearsal, Etiquette, 8. Friendly with sister pageants.

**JUDGES SCORING VALUES ON PAGEANT NIGHT: Introduction = 20%, Lifestyle & Fitness in Swimsuit = 20%, Evening Wear/Dress = 30%, On Stage Question = 30%. They will score you on pageant night on the following observations: Confidence with herself, no mistakes on speech, good presentation. Not nervous, happy, great answers, intelligence, good clothing, hair and make-up taste. Judges will not be scoring on the following: Body types.** All judges scores for each will be from 25 - 75 points.

**IMPORTANT NOTE: On day of pageant, we will have an independent accountant to add all the scores on his laptop computer so no errors will be made.
